What Investment Services and Advice Can You Provide Me?

We offer investment advisory services to retail investors. We provide discretionary investment management services, non-discretionary asset advisory services, and strategic asset consolidation services ("SACS"). When providing investment management and asset advisory services, we manage and continuously monitor your custodial accounts and provide you with continuous and ongoing supervision of your custodial accounts.

When discretionary authority is granted via execution of our investment advisory agreement, we will have the limited authority to determine the type and number of securities to be purchased or sold for your portfolio without obtaining your consent for each transaction. You may place reasonable restrictions on the types of investments that may be purchased or sold in your account so long as the restrictions are explicitly set forth. For non-discretionary services, you make the ultimate decision regarding the purchase or sale of investments

We offer advice with respect to various products and types of investments.

GIA has a stated account minimum of \$300,000 (or equivalent in other currencies) and does not recommend opening accounts with less than \$1,000,000 to ensure prudent diversification.

What Fees Will I Pay?

For investment management services, you will pay an annual fee based on the total assets under management. The fee is payable quarterly in arrears.

For non-discretionary advisory services, you will pay an annual fee based on the total assets advised plus a percentage surcharge.

For SACS services, you will pay a flat fee. Our fixed fee is payable fifty percent (50%) upon signing your agreement and fifty percent (50%) upon completion of services

We charge an asset-based fee which means that the more assets there are in the clients' advisory account, the more the client will pay in fees. As such, we may therefore have an incentive to encourage our clients to increase the assets in his or her accounts.

You may pay additional fees including custodian fees, fees related to mutual funds, and other transactional fees.
