Chi-Rho Financial is an investment adviser registered with the Securities and Exchange Commission (“SEC”). Investment advisory services and fees are different than the services and fees provided by a broker-dealer and it is important for you to understand the differences. There are free and simple tools available allowing you to research firms and financial professionals at www.investor.gov/CRS which also provides educational materials about broker-dealers, investment advisers and investing in general. The following items include Conversation Starters that the SEC created as a way to facilitate discussions between our firm and you.

What investment services and advice can you provide me?

We provide investment advisory services to high net worth retail investors. We offer services in both a **discretionary** and **non-discretionary** manner. In a non-discretionary account arrangement you make the ultimate decision regarding the purchase or sale of investments. In a discretionary account arrangement we make those decisions for you. We can help you decide which type of investment advisory services to seek based on our conversations with you and an assessment of your financial situation. We monitor your account investments on a continuous basis as part of our standard services and will confer with you via phone, email, and face to face to discuss your investments and any changes to your financial picture. The general minimum account size for which we offer investment advisory services is \$250,000.

What fees will I pay?

We charge **asset-based fees**. The types of fees we charge may create a conflict of interest to you. For example, an asset-based fee may incentivize us to encourage you to place more assets at our firm. In a traditional asset-based fee arrangement you may also be charged fees that are separate from our fees and may be charged directly or indirectly to you. These include but are not limited to custodian fees, account maintenance fees, mutual fund and variable annuity fees as well as other transactional and product-level fees.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means. We also manage five additional pooled investment vehicles in addition to the separately managed account. We may be incentivized to favor the pooled investment vehicles in an effort to earn higher fees,
