



## Form CRS – Client Relationship Summary

### Item 1 – Introduction

---

**Is an Investment Advisory Services relationship right for you?** Dynamic Advisors Solutions, LLC dba Dynamic Wealth Advisors (“Dynamic”) is an investment adviser registered with the U.S. Securities and Exchange Commission (“SEC”). Dynamic offers investment advisory services, not brokerage services.

Please be aware that brokerage and investment advisory services and fees are different and it is important for retail investors to understand the differences. ### Item 2 – Relationship and Services

---

**What investment service and advice can you provide me?** Dynamic offers a range of investment advisory services. If you enter into an investment advisory arrangement with our firm through one of our Financial Advisors, we will offer you advice pursuant to a written agreement. We will discuss your investment goals, help you to determine a strategy to achieve your investment goals, make recommendations, and regularly monitor your portfolio. We will contact you at least annually to discuss your portfolio.

You can choose an account that allows us to buy and sell investments in your account without asking you in advance (“**discretionary account**”) or we may give you advice and you decide what investments to buy and sell (“**non-discretionary account**”).

Financial planning is also offered as a separate service for an additional flat, hourly, or periodic fee. **Our Financial Advisors** provide a range of services under a planning agreement.

### Item 3 – Fees, Conflicts, and Standard of Conduct

---

**What fees will I pay?** As a client you will pay investment advisory and/or financial planning fees. Dynamic charges an **on-going asset-based fee** based on the value of cash and investments in your advisory accounts or a **fixed fee** as defined in your agreement. Our fees vary and may be negotiable. Our firm’s fees will be automatically deducted from your advisory accounts, which will reduce the value of your advisory account.

You may incur certain fees or charges imposed by third parties, other than Dynamic, in connection with investments made on behalf of your account. You are responsible for all custodial and securities execution fees charged by the custodians and executing broker-dealers. The fee we charge is separate and distinct from these custodian and execution fees.

If you enter into a separate financial planning agreement with us, you will pay a fixed fee, hourly fee or on-going planning fee.

You will pay fees and costs whether you make or lose money on your investments. Our asset-based fees increase as the value of your portfolios increases. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. Our financial planning fees and fixed fees are assessed regardless of the changes in the value of your portfolio.

**What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have? When we act as your investment adviser,** we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means. All investment advisers face conflicts of interest which are inherent in the business. Our primary source of compensation is through asset -based fees. Therefore, we are motivated to acquire new clients and to increase assets under management. If you agree with our financial planning recommendations to manage your investments, we would receive additional compensation for investment advisory services.

**How do your financial professionals make money?** Our Financial Advisors receive fees charged to your accounts and financial planning fees paid by you. Some of our Financial Advisors are engaged in other professions for which they receive additional compensation. These services are offered separate and apart from your Financial Advisor's relationship with Dynamic.
