Cantor Fitzgerald Investment Advisors (CFIA) is registered with the Securities and Exchange Commission as an Investment Advisor. Brokerage and investment advisory services and fees differ. It is important for the retail investor to understand the differences. Free and simple tools are available to research firms and financial professionals at <u>Investor.gov/CRS</u> which also provides educational materials about broker-dealers, investment advisers, and investing.

What investment services and advice can you provide me?

Our firm offers investment advisory services to retail and institutional investors. If you open an advisory account, you will pay an on-going *asset-based fee* each quarter for our services, based on the value of the cash and investments in your advisory account.

Cantor Fitzgerald Managed ETF Portfolios

CFIA will utilize both in-house and third-party research to construct Exchange Traded Fund (ETFs) model portfolios. We will review your investment goals and decide with you a model portfolio to achieve your investment goals. In addition, we will regularly monitor your account and will offer you advice on a regular basis. You should regularly review your portfolio with your financial advisor or with CFIA. Our investment advice will cover a significantly limited selection of investments. Our model portfolios will be comprised of only ETFs. Other firms could provide advice on a wider range of choices, some of which might have lower costs.

Cantor Fitzgerald Value & Income Strategy Portfolios

CFIA will provide advisory services utilizing a value approach with a focus on dividend yield and covered call option premium cash flow. We choose from a variety of securities to build investment portfolios which include, and are generally limited to, the following: publicly traded equities, corporate debt securities, municipal securities, mutual funds, exchange-traded funds (ETFs), money market instruments and covered call options. We also manage accounts as an adviser, subadvisor and/or research provider to sponsored, all-inclusive assetbased fee programs referred to as "wrap fee" programs. Portfolio-modeling research and retirement account consulting services are also offered on a limited basis. We provide advisory services to Cantor Fitzgerald mutual funds.

Your contract allows us to buy and sell investments in your account without asking you in advance (a "discretionary account").

What fees will I pay?

The amount paid to our firm does not vary based on the type of ETF model portfolio CFIA will select on your behalf. The *asset-based fee* reduces the value of your account and will be deducted from your account. An ETF can impose additional fees that will reduce the value of your investment over time.

The **CFIA** managed wrap fee program account fees include our advisory fee, execution charges on trades and custody fees. Wrap fee program account fees are asset-based fees and vary by program sponsor. Account consulting service fees are billed at a negotiated hourly fee.

Our fees vary and are negotiable. The amount you pay will depend on the amount of assets in your account.

You will pay a transaction fee when we buy and sell an investment for you. You will also pay fees to a broker-dealer or bank that will hold your assets (called "custody").

The more assets you have in the advisory account, including cash, the more you will pay us. We have an incentive to increase the assets in your account in order to increase our fees. You pay our fee quarterly even if you do not buy or sell.

YOU WILL PAY FEES AND COSTS WHETHER YOU MAKE OR LOSE MONEY ON YOUR INVESTMENTS. FEES AND COSTS WILL REDUCE ANY AMOUNT OF MONEY YOU MAKE ON YOUR INVESTMENTS OVER TIME. PLEASE MAKE SURE YOU UNDERSTAND WHAT FEES AND COSTS YOU ARE PAYING.

We sponsor and manage the Cantor Fitzgerald mutual funds. Our employees, may be shareholders of these funds. We may recommend that you invest in these funds as an alternative to investing in an independently managed account. Firm employees may also have an interest or position in securities recommended to you.
