Brokerage and investment advisory services and fees differ, and it is important for retail investors to understand the differences. Relationships and Services

What investment services and advice can you provide me?

We offer investment advisory services to retail investors.

Our financial planning services involve assisting clients with financial and cash management, risk management, financial issues relating to divorce or the death of a family member, insurance planning, estate planning, tax issues, retirement planning, educational funding, goal setting, or other needs identified by us or the client after a review of the client's financial circumstances. After collecting and reviewing the pertinent data and identifying goals, objectives, concerns, and potential solutions, we present the client with a written financial analysis.

Our portfolio management services involve managing individualized portfolios for our clients. We use a variety of securities, including bonds, common stock, options, exchange traded funds, exchange listed real estate investment trusts, mutual funds, and treasury bonds. We offer our portfolio management services on a discretionary and non-discretionary basis, depending upon what we agree to with the client. If we agree with the client to manage his or her account on a discretionary basis, we will be allowed to place trades without first obtaining the client's consent. We do not require a minimum account size in order to provide our portfolio management services.

Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?

We charge \$300 per hour for financial planning services; the number of hours will vary depending upon the complexity of the client's financial situation and the preparation required to address the client's financial issues and concerns. Our fee is due upon the signing of the financial planning agreement. If the client prepays fees in excess of \$1,200, our services will be completed within 6 months of the date we receive the fee.

For our portfolio management services, we charge an annual fee that is based on the assets under management in the client's account. The maximum annual fee is 1.95%. Our portfolio management fee is calculated and billed monthly in advance.

Because our portfolio management fees are based on the amount of assets in your account, this gives us an incentive to encourage clients to increase the assets in their accounts, because the more assets there are in the account, the more fees we receive.

In addition to our fees, there are other fees and costs that you may pay directly or indirectly, including charges imposed by custodians, brokers, third-party investment advisers, and other third parties such as fees charged by mutual fund and exchange traded fund managers, custodial fees, deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice that we provide to you. Here are some examples to help you understand what this means:

- (a) Some of our associates are independent insurance agents. They may recommend these services to our clients. These services pay the associates commissions that are separate from the fees we collect. This creates a financial incentive for these associates to recommend and sell insurance products to our clients.
- (b) We participate in TD Ameritrade's institutional customer program, which provides economic benefits to us that are typically not available to TD Ameritrade retail investors. This creates an incentive for us to recommend the use of TD Ameritrade for custodial or brokerage services.
- (c) When we recommend that you rollover a retirement account for us to manage, this creates a financial incentive because charge a fee for our services.

Our firm's principals are paid salaries and receive occasional dividends. Our other financial professionals are paid a percentage of our management fee. The firm's maximum management fee is 1.95% and our other financial professionals can receive up to 1.45% of the 1.95%.
