We are HD Money, Inc., an investment adviser registered with the Securities and Exchange Commission. Investment advisory and brokerage services and fees differ, and it is important for you to understand the differences. What investment services and advice can you provide me?

We offer customized investment advisory and financial planning services to retail investors. We offer advice on a full suite of securities, including equities, fixed income, mutual funds, ETFs, and similar investments. Our services are generally provided on a discretionary basis, which means that we have the power to buy and sell securities for your account without your prior consent. This authority is usually unlimited and remains in effect until you revoke it. For financial planning services, we do not exercise discretionary authority or require you to use certain advisors. We may provide non-discretionary investment advice, where we make investment recommendations to you and you decide whether to implement the recommendation. We do not give advice on any proprietary investment products.

We provide continuous and regular supervision of advisory client assets as part of our standard service to you. In addition, we will conduct ad hoc reviews if you change your objectives or risk tolerance, upon significant market and economic events, or if we change our investment strategy.

We do not require a minimum account size or fee.

What fees will I pay?

Our quarterly fees are calculated as a percentage of the assets under our management, so our fees will rise and fall with the value of the assets we manage for you. As a result, we are economically incented to recommend that you place more assets in your account in order to increase the value of your portfolio, because as the value increases, so do our fees. While our fees may reduce the amount of your assets available for investment, we believe they are justified by our services and attention to your needs. Nonetheless, we are economically incented to recommend that you place more assets in your account in order to increase the value of your portfolio, because as the value increases, so do our fees. In addition to our fees, you may be charged transaction or asset-based fees by your custodian for its services. These fees vary depending on the custodian. Under a transaction fee arrangement, the more transactions effected in your account, the more fees you will pay, and high activity in your account does not assure positive portfolio performance. For custodians that charge their fees based upon a percentage of your assets, such fees may be more than would be the case if you are charged a transaction-based fee. Please be mindful of the effect of your portfolio size, the level of activity, and the rate of custodian asset-based pricing. Generally, large portfolios would be disadvantaged by paying an asset-based custodian fee versus a transaction-based fee. Some securities carry additional costs, such as mutual funds and ETFs. Financial planning fees will be charged at a fixed rate as agreed upon by you and the firm.

There are additional fees such as internal fees and expenses charged by mutual funds (i.e., 12b-1 distribution fees and management fees that are assessed within the mutual fund) and exchange-traded funds, third-party separate account manager fees, product-level fees and commission for insurance-related products, postage and handling, transfer taxes, SEC fees for sales of securities.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

- Certain HD Money professionals are employees of Vimvest Securities, LLC, an affiliate investment adviser. This
 affiliation represents a conflict of interest in that HDM is under common control with Vimvest, thus creating an
 economic incentive for HD Money to utilize the Vimvest Portfolios, and conversely for Vimvest professionals to
 recommend the investment management services of HD Money.
- Certain of HD Money's advisory clients have invested capital in an affiliate of HD Money. Clients should be aware of certain conflicts of interest related to those investments: HD Money is incentivized to preference advisory clients who are investors in an affiliate versus those advisory clients that have not invested in an affiliate. Capital raised by the affiliate is used to enhance the overall technology platform available to the HD Money affiliate entities, including HD Money. A failure to attract or maintain sufficient growth capital could result in either a degradation of services or a failure to roll out new services that may have been a factor in clients' evaluation to engage HD Money. HD Money's advisory clients should be aware that any investment in an HD Money affiliate is outside the scope of their advisory relationship with HD Money. There is no ongoing responsibility for HD Money to make recommendations with respect to any investment by its advisory clients in any affiliate.
- Certain HD Money professionals are (i) licensed to sell insurance, and (ii) registered with Viewtrade Securities, Inc., a FINRA-registered broker-dealer, both of which create conflicts of interest regarding compensation.

We are incentivized to recommend that you add additional assets to your advisory account. We do not receive non-cash compensation.
