# **Item 2: Relationship and Services**

#### What investment services and advice can you provide me?

PF Advisors offers financial planning and continuous financial advice and guidance to retail investors on a Discretionary & Non-Discretionary basis. *Account Monitoring*. Client portfolios are monitored on an ongoing basis. The frequency of a portfolios rebalancing takes place when we at PF Advisors feel that there is an opportunity to sell into strength and buy into weakness. Any limitations regarding the investment process is first discussed with the client and then documented.

Investment Authority. We manage investment accounts on both a discretionary and a non-discretionary basis whereby we will provide advice. Discretionary investment management means that the Advisor makes the ultimate decision to invest in a specific investment. Non-Discretionary investment management means that the Client makes the ultimate decision to invest in a specific investment. You have an unrestricted right to decline to implement any advice provided by our firm. Subsequent buys and sells that are part of the rebalancing process of the portfolio do not need the client's approval.

*Investment Offerings*. We provide advice on various types of investments. Our services are not limited to a specific type of investment and/or product.

Account Minimums and Other Requirements. In general, we do not require a minimum dollar amount to open and maintain an advisory account. # Item 3: Fees, Costs, Conflicts, and Standard of Conduct

## What fees will I pay?

PF Advisors advisory fees are charged in arrears and are based on the market value of the assets under management and calculated as follows:

Account Value	Annual Advisory Fee
First \$2,500,000.00	1.00%
Next \$7,500,000.00	0.75%
Over \$10,000,000.00	Negotiated

PF Advisors fees are structured in a way that the more money a client has invested in an advisory account the more money the client has to pay in fees. PF Advisors has a decreasing annual advisory fee where the percentage (%) charged drops based on the amount of money the client has in the advisory account. This incentivizes PF Advisors to increase the account's value, both through organic growth of the account as well as through the client adding additional deposits. PF Advisors does not charge additional fees other than the advisory fees listed above and/or fees negotiated separately and agreed to prior. Mutual funds and ETFs have internal fees and expenses, in which PF Advisors does not receive or share in these

fees. PF Advisors clients may incur brokerage and other transaction costs by the custodian. PF Advisors does not receive these fees nor do we share in these fees; see ADV 2A Item 12 for additional information. #### **Standard of Conduct:**

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. An example of a conflict is PF Advisors receives additional compensation when a client adds money to increase the accounts value.

• How might your conflicts of interest affect me, and how will you address them?

#### How do your financial professionals make money?

PF Advisors investment advisory representatives are compensated based on the amount of client assets (i.e. Cash & Securities) under management in which they service.
