Planning Solutions International LLC operates in the state of Florida with the dba name of Let Bob. Relationships and Services

What investment services and advice can you provide me?

Services: We offer investment advisory services to retail investors. These services include comprehensive investment management which is a combination of financial planning and investment management. We may also offer financial planning as a stand-alone service. We work closely with you to identify your investment goals and objectives, as well as risk tolerance and financial situation in order to develop an investment approach.

Accounts, Investments, and Monitoring: We provide services to individual, joint, trust and estate accounts. We primarily use mutual funds, exchange-traded funds, stocks, and bonds, in constructing portfolios. We do not make available or offer advice with respect to only proprietary products or a limited menu of products or types of investments. As part of our standard services, we monitor portfolios and securities in accounts on a regular and continuous basis. We also offer to meet with you at least annually, or more frequently, depending on your needs.

Investment Authority: We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives without your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing.

Account Minimums & Other Requirements: We generally require a minimum relationship size of \$10,000 in order to effectively implement our investment process. This amount may be waived or reduced at our sole discretion.

Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?

Asset-Based Fees: Our asset-based fees for comprehensive investment management ranges up to 2.50% annually. This fee is collected on a monthly basis and calculated as a percentage of the value of the cash and investments in your account[s] that we manage. This presents a conflict of interest as we are financially incentivized to encourage you to place more assets in your advisory account as you will pay more in advisory fees.

Hourly Fees: Our hourly fees for financial planning are at a rate of \$150 per hour. fees may be invoiced up to fifty percent (50%) of the expected total fee upon execution of the financial planning agreement. With the invoiced and due upon completion of the agreed upon deliverable[s]. Hourly fees are negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. We provide you with an estimate for total hours and overall costs prior to engaging us for these services.

Fixed Fees: Our fixed fees for financial planning are at a rate of \$30 a month. Monthly fees due at the end of each month, Financial planning fees are negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. Robo Advisory services under Let Bob are at a range up to \$120.00 a month.

Other Fees & Costs: In addition to our advisory fee, you may also be responsible for custody fees, account administrative fees, fees and expenses related to mutual funds and exchange-traded funds and applicable securities transaction fees.

Additional Information: **You will pay fees and costs whether you make or lose money on your investments.** Fees and costs will reduce any amount of money you make on your investments over time. **What are your legal obligations to me when acting as my investment adviser?
How else does your firm make money and what conflicts of interest do you have?**

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.

Some of our financial professionals are licensed as insurance agents. In addition to our services, your financial professional will offer you insurance products in their separate capacity as an insurance agent. The fees charged for the implementation of insurance products are separate from our advisory fees, where your financial professional will earn commission-based compensation for the implementation of an insurance product. Therefore, there is a financial incentive to recommend that you implement insurance through our financial professionals.

How do your financial professionals make money?

Kendal Cann is compensated based on an agreed-upon annual salary. Additionally, she receives compensation based on the revenue generated from the accounts she services directly.

Mario Payne is compensated based on the revenue generated from advisory services, which is distributed in accordance with our partnership agreement. Mario Payne is also compensated from the sale of insurance products.

This means our financial professionals have an incentive to increase the asset size in the relationship or solicit new business, taking time away from the day-to-day servicing of existing clients.
