## What Investment Services and Advice Can You Provide Me?

**Description of Services:** The following are descriptions of the primary services of GreenPortfolio which are available at https://greenportfolio.com/ and https://mygreenportfolio.com/.

**Climate Scoring of Investment Portfolio** – Under this service, a client will utilize our interactive websites to assess common publicly traded securities for climate impact utilizing our algorithms. The data you provide to GreenPortfolio to perform a climate assessment may also be used by us to recommend third-party investment adviser(s). Please refer to Item 4 – *Advisory Business of our Form ADV Part 2A* for more details.

Third-Party Investment Advisors – Under this service, GreenPortfolio recommends one or more third-party investment advisers who can assist with your climate objectives based on your personal information. Our third-party investment adviser services are available only on our interactive website through our automated software and does not involve or include you working directly with our employees. You are never obligated or required to work with a third-party investment adviser firm recommended by GreenPortfolio. If you choose to engage a recommended third-party investment adviser, the third-party investment adviser is responsible for providing you the mutually agreed upon investment advisory services such as financial planning, making investment recommendations or decisions, continuously monitoring your accounts, and/or placing trades in your account when necessary. There will be resources on our interactive website for assisting you in making your decision to select an investment adviser. Through our website and follow-up email communications, we will invite you to schedule an introductory meeting with one or all of the third-party investment adviser(s) we recommend. Once you have selected a third-party investment adviser and enter your account information into our system, Climate Scoring of your investment portfolio holdings managed by the third-party investment manager will be performed on an ongoing basis. Additionally, on an ongoing basis, we will provide you an annual due diligence report about certain aspects of your third-party investment adviser. You may request at any time that we recommend an alternative investment adviser. Please refer to Item 4 – Advisory Business of our Form ADV Part 2A for more details.

**Limited Investment Offerings:** Other than scoring investment portfolios for climate purposes and recommending third-party investment adviser(s), GreenPortfolio does not provide advice on specific investments, types of investments, asset classes or investment strategies. Please refer to Item 8 – *Methods of Analysis, Investment Strategies and Risk of Loss of our Form ADV Part 2A* for more information.

**Account & Fee Minimums:** There are no minimum investment amounts or conditions required for our climate scoring program or our third-party investment adviser service. However, all clients are required to consent to our terms of services.

## What Fees Will I Pay?

However, GreenPortfolio will receive a referral fee from the referred third-party investment adviser firm recommended by us and selected by you. # What Are Your Legal Obligations to Me When Acting as My Investment Adviser? How Else Does Your Firm Make Money and What Conflicts of Interest Do You Have?

**Standard of Conduct:** When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means. When we recommend that you utilize a third-party investment advisor, we will receive a percentage of the fee which they collect from you. This creates a conflict of interest as we have an incentive to recommend managers who have such arrangements with us. We have a conflict of interest by only offering those third-party investment advisers that have agreed to pay a referral fee to us and have met the conditions of our review. There may be other third-party investment advisers that may be suitable for you that may be less costly.
