We are registered with the SEC as an investment adviser. Brokerage and investment advisory services fees differ, and it is important for you to understand the differences. ### Relationships and Services

#### What investment services and advice can you provide me?

Our firm offers investment advisory services, which are fully described in our Form ADV Part 2A ("Disclosure Brochure"). Our services include asset allocation, portfolio management and investment analysis. As part of our standard services, we monitor investments that we manage at least on a quarterly basis. We accept discretionary authority to implement the recommended transactions in client accounts. The level of discretion is determined in our agreement and there are no material limitations on the authority. We do not offer advice only with respect to proprietary products. We offer advice on mutual funds and exchange-traded funds ("ETFs"). Your account may also have individual debt and equity securities and options. Where appropriate, we provide advice about any type of legacy position or other investment held in your portfolio; however, you should not assume that these assets are being monitored on a quarterly basis or otherwise advised on by us unless specifically agreed upon. Our services are subject to a \$1,000,000 minimum account size.

### Feeds, Costs, and Standards of Conduct

#### What fees will I pay?

The fees for these types of services are negotiated between the client and the Firm. Fees for investment management are 1.00% per annum of assets under management.

In addition to the advisory fees paid to us, you also incur certain charges imposed by other third parties, such as broker-dealers and custodians. These charges may include securities brokerage commissions, transaction fees, custodial fees, fees charged by independent managers, margin costs, charges imposed directly by a mutual fund or ETF in a client's account as disclosed in the fund's prospectus (e.g., fund management fees and other fund expenses), deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions.

The more assets there are in your advisory accounts, the more you will pay in fees, so the firm may therefore have an incentive to encourage you to increase the assets in your account or manage them in a way where we receive higher fees. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

***When we act as your investment adviser,*** we are obligated to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. The following is an example to help you understand what this means:

- Our firm and/or its investment advisory representatives may from time-to-time purchase or sell products or investments that they may recommend to clients. In such circumstances, our firm or its investment adviser representatives may have a financial interest in recommending investments that our firm or its representatives also own.

Our financial professionals are compensated based on the following factors and conflicts of interest: Seal Cove Capital, LLC and its investment adviser representatives receive compensation based on a percentage of your assets under management. As the value of your assets under management increases, total compensation you pay to Seal Cove Capital and its representatives also increases. However, if your account value decreases, you still pay a fee to Seal Cove Capital and its representatives.
