ViaQuest Advisors, LLC ("VQA") is an investment adviser registered with the Securities and Exchange Commission ("SEC"). Brokerage and investment advisory services fees differ, and it is important for you to understand the differences. Relationships and Services

What investment services and advice can you provide me?

Our firm provides the following investment advisory services: financial planning and portfolio management services, and pension consulting services.

- *Investment Authority:* We primarily manage investment accounts on a discretionary basis. A *discretionary account* allows us to buy and sell investments in your account without requiring your pre-approval on an ongoing basis until you notify us to change this arrangement. You may limit our discretionary authority (for example, limiting the types of funds that can be purchased or sold for your account) by providing our firm with your restrictions and guidelines in writing. We also offer non-discretionary services whereby we provide investment advice and you make the decision about the purchase or sale of each asset.
- Monitoring: VQA monitors your investments at least annually as part of our standard service.
- Account Minimums: VQA has a minimum investment account balance of \$50,000. Generally, this minimum investment account requirement is negotiable.

Fees, Costs, and Standards of Conduct

What fees will I pay?

Portfolio Management fees vary depending on the services you receive. Additionally, the amount of assets in your account affects our advisory fee; the more assets you have in your advisory account, the more you will pay us and thus we have an incentive to increase those assets in order to increase our fee. Asset management fees range between 0.70% and 1.00%. Portfolio Management fees are payable monthly in advance, based on the previous month's average daily balance Our hourly rate for Financial Planning is \$200, due upon services rendered. Some investments (e.g., mutual funds, variable annuities, etc.) impose additional fees (e.g., transactional fees and product-level fees) that reduce the value of your investment over time. You will also pay fees to a custodian that will hold your assets. You pay our fees even if you do not have any transactions and the advisory fee paid to us generally does not vary based on the type of investments selected. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we are obligated to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. The following is an example to help you understand what this means:

- Our firm and/or its investment advisory representatives may from time-to-time purchase or sell products or investments that they may recommend to clients. In such circumstances, our firm or its investment adviser representatives may have a financial interest in recommending investments that our firm or its representatives also own.
- Persons providing investment advice on behalf of our firm are licensed as independent insurance agents. These persons will earn commission-based compensation for selling insurance products. Insurance commissions are separate and in addition to our advisory fees. This practice presents a conflict of interest because they have an incentive to recommend insurance products to you for the purpose of generating commissions rather than solely based on your needs.
- Our firm is compensated based on the assets that we manage. This means there is an incentive for our advisors to increase your account value, which creates a conflict of interest.
