

Client Relationship Summary – June 2025

Westmark Wealth Management is an investment adviser registered with the U.S. Securities and Exchange Commission. Investment advisory and brokerage services and fees differ; therefore, it is important for you to understand the differences.

Free and simple tools are available to research firms and financial professionals at Investor.gov/CRS, which also provides educational materials about investment advisers, broker-dealers, and investing.

What investment services and advice can you provide me?

We offer investment advisory services to retail investors, including asset management, that will be provided by unaffiliated money managers or investment advisors through SMAs and managed account programs sponsored by third-party providers (each a “third-party manager”). We will assist and advise clients in establishing investment objectives for the third-party manager, including any sub-advisors, and continue to provide oversight of the account and ongoing monitoring of the activities of the third-party manager. As part of our standard services, we monitor our clients’ portfolio holdings and the overall asset allocation strategy implemented by third-party managers on an ongoing basis, or when market conditions or other triggers would warrant a review. Triggers include a change of investment objectives, a change in employment, or a change in recommended asset allocation weightings. We also offer non-discretionary investment consulting services to clients seeking investments in alternative products that cannot be managed by us on a continuous and ongoing basis. Our consulting services will include recommendations or suggestions of alternative investments, as well as assistance with all administrative paperwork and fund transactions.

We offer our investment advisory services on a discretionary basis. Discretionary management allows us the limited authority to direct buying and selling of investments in your account by third-party managers without asking you each time a transaction is placed. Our level of authority is determined at the beginning of our relationship with you in our advisory agreement but can be changed upon request.

We provide investment recommendations and will direct third-party managers to construct portfolios primarily using exchange-traded equity securities (i.e., stocks and ETFs), variable annuities, and mutual funds. We do not have any minimum requirements for opening or maintaining accounts for retail investors.

Conversation Starters – Ask Your Financial Professional:

What is your relevant experience, including your licenses, education and other qualifications? What do these qualifications mean?

What fees will I pay?

Principal Fees: We are compensated for providing the investment advisory services by charging an ongoing asset-based fee that ranges up to 1.25% per annum depending on the type and complexity of the investment management strategy employed, as well as the size of the account or overall client relationship. Our fees are based on a tiered rate schedule where the rate declines for incremental assets as the account size increases. The fees are paid quarterly in advance. With the asset-based fee, the more assets there are in your advisory account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account. Advisory fees are negotiable based at our discretion. Investment consulting services clients will pay a one-time fixed fee, in advance, of up to 0.75% of the client’s investment principal.

Other Fees and Costs: In consideration for their services, third-party managers will also charge asset-based investment advisory fees that includes the investment advisory fee of any sub-advisors, the administration of the program and trading, clearance, and settlement costs. Westmark Wealth Management’s investment advisory fee will be included in the third-

party manager fees and will be directly deducted from the account by the third-party manager. Westmark Wealth Management's fees are exclusive of brokerage commissions, transaction fees, and other related costs and expenses which shall be incurred by the client. You may incur certain charges imposed by custodians, brokers, custodial fees, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions. All fees paid to Westmark Wealth Management for investment advisory services are separate and distinct from the fees and expenses charged by mutual funds and ETFs to their shareholders, which are disclosed in the funds' prospectuses.

Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce the amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. **More detailed information about our fees and costs are included in our Form ADV Part 2A (Item 5).**

Conversation Starter – Ask Your Financial Professional:

Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we must act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.

Investment advisor representatives (IARs) of Westmark Wealth Management are also licensed and registered as insurance agents to sell various insurance products. Therefore, they will be able to purchase insurance products for clients in need of such services and will receive separate, yet typical commission compensation for the purchase of those products. While the IARs are required as fiduciaries to put the interest of the clients first, the receipt of additional compensation itself creates a conflict of interest. You are under no obligation to purchase insurance products through Westmark Wealth Management's IARs. **These arrangements and additional information about other conflicts of interest are discussed in more detail in our Form ADV Part 2A.**

Conversation Starter – Ask Your Financial Professional:

How might your conflicts of interest affect me, and how will you address them?

How do your financial professionals make money?

Our IARs are compensated through the receipt of a portion of revenue we receive for the advisory services we provide. The portion paid to your IAR generally does not vary based on the type of investments that are recommended.

Do you or your financial professionals have legal or disciplinary history?
