ITEM 1. INTRODUCTION

AXXETS WM is an investment adviser registered with the Securities and Exchange Commission (SEC). We provide investment advisory services to our clients through various types of discretionary and non-discretionary accounts in accordance with each client's investment objectives. Discretionary accounts provide AXXETS WM the authority to make investment decisions on behalf of the client. Non-discretionary accounts, on the other hand, leave the ultimate decision regarding the purchase or sale of investments solely on the client. Investment activities focus on investments in various kinds of assets and securities in a variety of markets that are intended to fit the client's objectives, strategies, and risk profile as described by each client. As an investment advisor, the Firm's principal business is to provide fee-based investment advisory services. It is important for the retail investor to know that the fees paid to us and the services we provide to you are different from the fees and services associated with your bank or broker-dealer. AXXETS WM provides investment advisory services, consulting services, family office services and ongoing portfolio management services, as agreed with each client individually. At no time will AXXETS WM accept or maintain custody of a client's funds or securities.

ITEM 2. RELATIONSHIPS AND SERVICES

Q: "What investment services and advice can you provide me?" At AXXETS WM, we evaluate your investment profile as well as your current investments and determine whether these complement each other. We will meet with you to determine your investment objectives, risk tolerance, and other relevant information. Using this information, we gather at the beginning of our advisory relationship, we outline your current investment profile, or Investment Policy Statement, (income, tax levels, and risk tolerance levels). In some cases, we may modify the portfolio based on the client's individual needs, financial objectives and risk tolerance. AXXETS WM 's cumulative minimum account is \$5,000,000; however, based on facts and circumstances AXXETS WM may, at its sole discretion, accept accounts with a lower value. Once we assess an investment strategy for you and, as a standard service, we will monitor your portfolio's performance on an ongoing basis and will rebalance the portfolio as required by changes in the model, market conditions and in your financial circumstances. ITEM 3. FEES, COSTS, CONFLICTS AND STANDARD OF CONDUCT

Q: What fees will I pay? AXXETS WM offers advisory services for a fee that is set in and governed by the Advisory Agreement between you, as the Client, and AXXETS WM, as the Investment Advisor. The following summarizes the principal fees and costs associated with engaging our firm for investment advisory services. Fees are paid on either a monthly or quarterly basis, in advance, at the client's discretion and as agreed in the advisory agreement, based on the gross asset value of the financial assets managed by the Firm as of the last business day of each period, or calculated based on the official value of the accounts or portfolios as reported by the financial institutions that act as brokers, and/or custodians for you, the Client.

As a retail investor, you may ask a financial professional the following questions to start a conversation about the impact of fees and costs to your investments: "Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?"

The fees charged to each client are a function of the type and size of the client's portfolio. Our maximum annual fee is 1%. These fees may be negotiated by the advisor under unusual circumstances, at the sole discretion of the advisor. Generally, asset management fees will automatically be deducted from the client's account on a monthly/quarterly basis by the custodian where you have your account, except for those accounts with a Performance Fee Agreement (if and when applicable). The Firm may also provide certain specified services for a fixed, non-asset-based fee. Clients may negotiate the fees they agree to pay for this specified service as they vary depending on the nature and complexity of services to be provided. If you have a net worth greater than \$2,200,000, you may qualify, and elect to pay, a fee based on the capital gains in your account(s), known as a "Performance Fee". Ask us about the requirements, terms, and conditions applicable to Performance-based advisory fees. Clients that are paying a performance-based fee should be aware that investment advisors have an incentive to invest in riskier investments when paid a performance-based fee due to the higher risk/higher reward attributes. All fees paid to the Firm for investment advisory services are separate and distinct from brokerage commissions, transaction fees, custodian fees and custodian charges, and other costs and expenses related to your investment account and securities transactions. These transaction charges are paid to, and retained by, the account custodian for its clearance and execution services. We do not receive any portion of these commissions, fees, or costs. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. Also, you need to understand the material risks that are associated with our investment strategies.

Q. "What are your legal obligations to me when acting as my investment advisor? How else does your firm make money and what conflicts of interest do you have?" When we act as your investment adviser, we must act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are two examples to help you understand what this means: **Performance Fees.** *Clients that are paying a performance-based fee should be aware that investment advisors have an incentive to invest in riskier investments when paid a performance-based fee due to the higher risk/higher reward attributes.*

Q. How might your conflicts of interest affect me, and how will you address them? To address and mitigate potential conflicts of interests, AXXETS WM has developed written policies and a Code of Ethics. We will notify you in case additional conflicts ever arise. Q. How do your financial professionals make money? AXXETS WM's compensation for investment professionals is based on individual arrangements with each employee. Our Advisors may receive a fixed salary, variable compensation based on their assets under management and the advisory fees charged to our clients or a combination of both.
