On August 2, 2016, James F. Barksdale, founder and majority owner of Equity Investment Corporation (EIC), entered into an Asset Purchase Agreement to sell certain of the assets of EIC to Equity Investment Corporation Acquisition, Inc. (EICA), also an SEC-registered Investment Adviser formed in June 2016 by three portfolio managers and registered investment adviser representatives of EIC: W. Andrew Bruner, CPA, CFA; R. Terrence Irrgang, CFA; and Ian Zabor, CFA, each of whom is a one-third owner of EICA. The closing date of the purchase and sale transaction was September 30, 2016. Among the assets sold is the right to use the names Equity Investment Corporation and EIC, the investment track record for all products and activities, substantially all the client relationships of EIC, and all trademarks, trade name rights, copyrights and other intellectual property rights related to any of the assets. On September 30, 2016, EIC filed articles of amendment with the Georgia Secretary of State changing EIC’s name to JFB Holdings Corp (“JFB Holdings”) and EICA changed its name to and is doing business as Equity Investment Corporation, or EIC. Many JFB Holdings’ clients have consented to the assignment of their accounts to EIC. However, some clients have not yet given consent to the assignment of their account to EIC and will continue to be serviced by JFB Holdings on behalf of EIC until unassigned contracts have been assigned or terminated. Messrs. Barksdale, Bruner, Irrgang and Zabor collectively have more than 40 years of combined investment experience, and they continue as portfolio managers for JFB Holdings during the transition period. JFB Holdings is not soliciting nor has any intentions of onboarding new clients. During the transition period, JFB Holdings has contracted with EIC for EIC employees to provide services as needed to JFB Holdings, including the three portfolio managers of EIC who manage the All-Cap Value, Large-Cap Value, and Mid-Cap Value strategies and the Investment Advisor Representatives (“IARs”) who serve as IARs of JFB Holdings. When all clients have either consented to the assignment of their contracts to EIC or terminated their contracts with JFB Holdings, JFB Holdings will discontinue its investment advisory business, withdraw its registration and surrender and terminate all Powers of Attorney for any and all clients.
