The SEC,in a no-action letter dated February 21, 2017, addressed to the Investment Adviser Association, provided relief from the custody surprise audit for these types of accounts when certain conditions set out in the letter are met. Our custodian has represented to Goldstein Munger that they have achieved compliance with all applicable conditions of the SEC’s no-action letter. Furthermore, and in satisfying the remaining condition in the SEC no-action letter, Goldstein Munger is not affiliated with nor are we located at the same address of our clients’ qualified custodian. (ii)One client account with assets of \$5,804,904.43 which is included in the total amount of assets under custody but was not subject to the 2021 audit requirement because the account was opened after the 2021 audit review period.
