TIMBERVEST AND ITS PRINCIPALS ARE ALLEGED TO HAVE ENGAGED IN THE UNAUTHORIZED SALE OF CERTAIN OF THE FUND'S ASSETS TO AN AFFILIATED TIMBERVEST FUND THROUGH THE USE OF A THIRD PARTY "MIDDLEMAN" THEREBY CONSTITUTING A PROHIBITED USE OF THE ASSETS OF BOTH FUNDS. THE PRINCIPALS ARE ALSO ALLEGED TO HAVE RECEIVED UNAUTHORIZED AND UNDISCLOSED REAL ESTATE COMMISSIONS IN CONNECTION WITH THE SALE OF CERTAIN ASSETS OF THE FUND CONSTITUTING A FURTHER PROHIBITED USE OF THE FUND'S ASSETS.
