Mariner will affect such withdrawal only if and when it determines in its sole discretion, that it fully qualifies for, and can rely on, the applicable registration relief and it otherwise satisfies Mariner’s business objectives consistent with its fiduciary and other client obligations. Following any such withdrawal, Mariner would no longer be subject to CFTC or NFA registration, examination, or ongoing regulatory oversight, and investors would not receive the protections afforded by CFTC or NFA regulation.
