TITAN/HICKMAN HAD NO REASON TO BELIEVE GILCHRIST WAS DISSATISFIED WITH THE ADVISORY SERVICES PROVIDED PRIOR TO THE TERMINATION OF THE RELATIONSHIP. BETWEEN AUG. 2000 AND MAR. 2003 THE BROAD EQUITY MARKET DECLINED APPROXIMATELY 39% AS REPRESENTED BY THE NYSE COMPOSITE INDEX. CHARLES SCHWAB & CO.("SCHWAB") SERVED AS THE CUSTODIAN/BROKER-DEALER FOR HER IRA; SCHWAB SENT GILCHRIST MONTHLY STATEMENTS LISTING ALL INVESTMENT POSITIONS. GILCHRIST COMMUNICATED TO JAMES HICKMAN ("HICKMAN") HER DESIRE TO HAVE AN INVESTMENT PORTFOLIO SIMILAR TO WHAT HER SISTER HAD BEEN ENJOYING AS A RESULT OF TITAN'S EFFORTS. TITAN/HICKMAN HAD NO REASON TO BELIEVE GILCHRIST WAS DISSATISFIED WITH THE ADVISORY SERVICES PROVIDED PRIOR TO THE TERMINATION OF THE RELATIONSHIP. BETWEEN AUG. 2000 AND MAR. 2003 THE BROAD EQUITY MARKET DECLINED APPROXIMATELY 39% AS REPRESENTED BY THE NYSE COMPOSITE INDEX.
