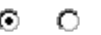

IN CONNECTION WITH THE ACQUISITION OF THE DOW SHARES, THE THREE FUNDS MADE THE REQUIRED HSR FILINGS. ONCE THE MERGER WAS FINALIZED ON AUGUST 31, 2017, THE DOW SHARES CONVERTED TO SHARES OF THE NEWLY FORMED DOWDUPONT INC.
