Canaras and Saranac are together filing a single Form ADV in reliance on the position expressed in the SEC's response to a January 18, 2012 letter sent to the SEC's Division of Investment Management by the American Bar Association (Re: Registration of Related Persons under the Investment Advisers Act of 1940 . . . by the Dodd-Frank Wall Street Reform and Consumer Protection Act . . .). (2) Total assets under management may fluctuate from time to time due to market conditions and the addition and deletion of accounts. (3) Information as to the number and location (domicile) of investors in any of the funds may change due to sale of interests to other parties. Canaras may not track such sales or assignments. CLO notes are listed on Euronext Dublin. Sales and assignments of notes in CLOs differs from those of hedge funds. Offerings of CLO notes and equity are pursuant to their own offering memoranda and are effected through the respective dealers. Such dealers are required, under applicable FINRA and other legal requirements, to perform anti-money laundering and know your customer reviews on subscribers to CLO securities. (4) The number of investment-related professionals is determined by assessing the involvement in portfolio decisions of each employee, and the number may fluctuate from time to time.
