JB WEALTH MANAGEMENT WAS THE GENERAL PARTNER OF HADDINGTON FUND, LP AT THE TIME. HADDINGTON FUND LENT BRIDGE LOAN CONSTRUCTION FUNDS TO BRADLEY KIDWELL FAMILY LP FOR RENOVATION OF BUILDINGS PROJECT. THE PROJECT WAS SUPPOSED TO TAKE 2 YEARS AT A COST OF NO MORE THAN \$2,000,000. HOWEVER AFTER 4 YEARS (2 YEARS OVERDUE) AND \$2,500,000 BEING LENT ON THE PROJECT (\$500,000 MORE THAN PROJECTED BY BORROWER), THE PROJECT WAS ONLY 25% COMPLETE. BORROWER DEFAULTED ON THE TERMS OF THE LOAN. THEREFORE HADDINGTON STOPPED LENDING AND THE BORROWER STOPPED PAYING INTEREST AND PRINCIPAL ON THE LOANS AND FILED FOR BANKRUPTCY.
