IN APRIL 2016, BHWM AND MARGARET BLACK WITHHELD PREPAID, UNEARNED ADVISORY FEES TOTALING \$131,000 FROM 63 DEPARTING CLIENTS WHO REQUESTED TERMINATING THEIR ADVISORY RELATIONSHIP WITH BHWM DESPITE REPRESENTATIONS MADE IN ITS FORM ADV BROCHURES AND ADVISORY AGREEMENTS. SPECIFICALLY, THE FIRM AND MARGARET BLACK INITIALLY REFUSED TO RECOGNIZE CLIENTS' E-MAILS AND MAILED REQUESTS AS PROPER TERMINATION NOTICES, INSTEAD DEMANDING THAT THE CLIENTS SEND WRITTEN REQUESTS WITH A "WET SIGNATURE," WHICH REQUEST WAS CONTRARY TO THE DISCLOSURES MADE TO CLIENTS IN BOTH THE FORMS ADV, PART 2A (THE "FIRM BROCHURES") AND ITS ADVISORY CONTRACTS.
