ON JULY 16, 2018, WITHOUT ADMITTING OR DENYING ANY FINDINGS IN THE ORDER, MOUNT KELLETT CAPITAL MANAGEMENT LP CONSENTED TO THE ENTRY OF AN ORDER TO CEASE AND DESIST FROM COMMITTING OR CAUSING ANY FUTURE VIOLATIONS OF SECTION 13(D) OF THE EXCHANGE ACT AND RULE 13D-1 PROMULGATED THEREUNDER, AND SECTION 206(4) OF THE ADVISERS ACT AND RULE 206(4)-7 PROMULGATED THEREUNDER. THE SEC FOUND THAT MOUNT KELLETT WAS AT LEAST 45 DAYS LATE IN SWITCHING FROM FILING A SCHEDULE 13G AS A PASSIVE INVESTOR IN A PORTFOLIO COMPANY TO FILING A SCHEDULE 13D AS AN ACTIVE INVESTOR, PURSUANT TO SECTION 13(D) OF THE SECURITIES EXCHANGE ACT OF 1934 AND RULE 13D-1 THEREUNDER. THE SEC ALSO FOUND THAT MOUNT KELLETT'S THEN-EMPLOYEE, NORMAN M. K.
