USING THE MOST EXPENSIVE LISTINGS FOR IDENTICAL EQUIPMENT LISTED FOR SALE ON E-BAY, THE "FAIR MARKET VALUE" OF THE EQUIPMENT WAS AT ITS HIGHEST ABOUT \$2,200. I OFFERED WELLS FARGO THIS AMOUNT IN FULL SATISFACTION OF OUR LEASE OBLIGATION. TAUFEN FLATLY REFUSED AND TOLD US THAT WELLS FARGO WOULD ONLY ACCEPT A MINIMUM OF \$5,000 IN CASH, OR THE AMOUNT ABOVE IN INSTALLMENTS. I REITERATED MY OFFER TO TAUFEN, BUT HE ALWAYS BELLIGERENTLY DEMANDED THE HIGHER AMOUNTS. IN ADDITION, TAUFEN REFUSED TO GIVE US THE ADDRESS FOR HIS "WAREHOUSE" SO WE COULD RETURN THE EQUIPMENT.
