ACP Associates and ACP Trust Associates vehicles invest alongside the main funds and do not operate under the traditional commitment model of the main funds. (1) Investors in the ACP Associates vehicles choose an investment level each year, as opposed to a set commitment level, to the corresponding active main fund, and as such each investor's commitment to the vehicles during the investment period is subject to adjustment on an annual basis. (2) Each investor is able to satisfy those investments through either the ACP Associate vehicle or the ACP Trust Associate vehicle or a combination of both. For investors who choose to satisfy investments through both, the commitment is combined across the two vehicles. This allocation between the two vehicles is determined by the investor on a deal-by-deal basis. As the main fund becomes closed to new investments, these investors are then only called for follow-on investments as they occur, and if so, are called for those investments in proportion to the allocation they chose for those deals when the fund initially invested in those investments. One notable difference is that ACP Associates, LLC and ACP Trust Associates, LLC invested alongside both ACP Fund I and ACP Fund II. For purposes of Items 14, 15 and 16 of section 7.B(1)A of Schedule D, for each master fund, we have presented information with respect to all feeder funds on a flow-through basis (i.e., we have looked through to the feeder fund to determine the indirect percentage of Related Persons, Funds of Funds and Non-US Persons).
