For this other-than-annual amendment, only certain items have been updated per the Form ADV Part 1A instructions following the acquisition of Janus Henderson Group PLC and its transition to private ownership. Item 5L.(1)(b) is answered "Yes" because the Adviser provides specific investment advice in its advertisements but does so in compliance with the requirements of the rule, meaning that it is fair and balanced. Item 5L.(1)(d) is answered "Yes" solely because the Adviser compensates third parties for endorsements. The advertisements that the Adviser distributes do not contain such statements. Question 15(a) in Section 7.B.(1) of Schedule D for VPC Specialty Lending Investments PLC is answered: "0%", as the Adviser does not maintain a "Funds of Funds" category in its records. The Adviser provides investment management services to VPC Specialty Lending Investments PLC, a company listed on the London Stock Exchange. However, the Adviser notes that 24% of VPC Specialty Lending Investments PLC was held by other funds as of December 31, 2025. The response to Question 23(a)(2) in Section 7.B.(1) of Schedule D for VPC Specialty Lending Investments PLC and VPC Investor Fund W, L.P. is “No” because the annual audited financial statements are prepared in accordance with the International Financial Reporting Standards ("IFRS"). The Adviser responded “0%” to Question 27 in Section 7.B.(1) of Schedule D for all of its private funds. However, the Adviser engages a third-party service provider to regularly review internal valuations that are being performed on investments which are valued using unobservable inputs. Related to Section 7.A of Schedule D, the Adviser has additional related persons who are not listed in Section 7.A because they are not involved in any of the enumerated activities or are otherwise permissible to exclude per the instructions. VPCA maintains a list of all related persons and will provide such list upon request. Janus Henderson US (Holdings) Inc. holds 53% of Victory Park Capital Advisors, LLC ("VPC"). Janus Henderson US (Holdings) Inc. is indirectly owned by Janus Henderson Group LTD. (together “JH”). The Adviser discloses Janus Henderson US (Holdings) Inc in Schedule A as a Control Person. However, while the definition of “Control” in Form ADV would presume control, JH does not have or exercise a controlling influence over the management or policies of VPC. Similarly, the newly added Jupiter entities in Schedule B do not have or exercise a controlling influence over the management or policies of VPC. Similarly, for the purposes of completeness and disclosure, we have listed Privacore Capital Advisors, LLC (“Privacore”) as a related person in Section 7.A of Schedule D as they are also owned by JH and serve as the advisor to a fund that VPC provides investment management services to as a sub advisor. Since VPC is not under common control with JH, VPC is not under common control with Privacore.
