D., as of December 31, 2025, the adviser had one advisory client (which was included in the advisory client count), but did not contribute to the adviser's RAUM, since it does not qualify as a securities portfolio. In Section 7.A. of Schedule D we have disclosed The Canada Life Assurance Company and only those related persons that are subsidiaries of Sagard Holdings Inc. Specifically, the parent corporation of Sagard Holdings Inc. is Power Corporation of Canada, a publicly listed diversified management and holding company. Power Corporation of Canada owns a large number of businesses which operate in the investment industry. With the exception of The Canada Life Assurance Company, we have opted not to disclose these related persons in Section 7.A. of Schedule D where we have no ordinary course business dealings with these related persons, do not conduct shared operations with these related persons, have no referral arrangements with these related persons, do not share supervised premises with the related persons and have no reason to believe that our relationship with the related person creates a conflict of interest with our clients. Relatedly, the parent company of The Canada Life Assurance Company, Great-West Lifeco Inc. and its subsidiary Empower Securities Holdings, LLC, both holding companies, have also been excluded. In accordance with the Form ADV FAQ’s updated on September 29, 2017, a supplementary list of related persons who are not listed in Item 7.A., along with the reason for why they are not listed, can be produced upon request. In response to Section 7.B.(1) -Question A.11, the values reported for most private funds are based upon the Adviser's calculation of regulatory assets under management (as of December 31, 2025) and do not reflect the gross asset value of the underlying real estate assets for each fund, which is typically a significantly higher value. For the purposes of the response to question 14 of Section 7.B.(1) with respect to GWL USPF LP, we have treated the investments therein by other funds advised by the Firm or otherwise subject to common control with the Firm, as investments by related persons. In response to Items 9.A.(2) and 9.B.(2), the firm has reported the amount of client funds and securities and total number of client accounts for which the adviser has custody in Item 9.A.(2). In certain cases, the firm’s related persons may also be deemed to have custody over some of the same assets and accounts as well (e.g., as manager of a pooled investment vehicle client); however, given the concern regarding not double reporting custodial assets implied in the instruction to Item 9.A.(2), and since the firm has direct

custody of such assets, such assets and client accounts have not been reported a second time in response to Item 9.B.(2). The individuals identified on Schedule B of this Form ADV as the trustees of The Desmarais Family Residuary Trust, formed under the laws of Quebec on October 8, 2013 under the Last Will and Testament of Paul G. Desmarais (the "Trust"), also act as voting administrators.
