While the fund was launched in late 2025 and capital was committed, as reflected in the vehicle's reported gross asset value, no capital was called prior to the end of 2025. As a result, neither the Firm nor either fund GP had custody of any client assets as of 12/31/2025. Going forward, fund financial statements will be audited and distributed to investors.
