These activities do not take place during market hours, or at times when clients wish to meet with him. As the firm grows, these practices should slow to a halt. However, until then, Deaver requires the income while the firm grows. This practice will take place under the firm's name of Deaver Financial. Section 6.A. Deaver Financial offers Bookkeeping as a service. The firm will assign a IAR to reconcile bank statements, create a net worth sheet, and inform the client of their current financial situation. Section 6.B. The Pre-Tax Prep is a form of a service to assist people who only have a strong relationship with management. Deaver Financial and Gregory Deaver acknowledge that they are not CPAs and will never gain the ability to become CPAs. This is a service that works along side with the client's CPA. Deaver Financial will not file taxes nor keep records of the tax prep process. Deaver Financial will merely assist with filling out the Tax Organizer provided by any licensed CPA. If the client does not have a CPA and requests one, Deaver Financial may recommend one. Other than that, Deaver Financial and the owner, Gregory Deaver, will leave taxes to the professionals. Tax organizers are provided by the CPAs and not by Deaver Financial. Deaver Financial does not share an office with any CPA nor do they receive referral benefits of any kind. Quells Emplorium, LLC Gregory Deaver owns 40% of Quells Emplorium, LLC as a strictly passive stake. He has been told by the owner that he would like Deaver Financial, LLC to manage their portfolio in the future. Thus creating a conflict of interest, but it is now disclosed.
