Thorofare’s pooled investment vehicle clients, as described in its Brochure, rely on the exceptions from the definition of “investment company” provided in Section 3(c)(5) of the Investment Company Act of 1940. Information regarding these entities has not been included in response to Schedule D, Section 7.B. (1), but is available to the SEC upon request. Regulatory assets under management are calculated to include gross assets (which includes gross loan commitments) plus committed capital. As further clarification to Item 9.B.(2), the total dollar amount with respect to which Thorofare has custody does not reflect uncalled capital commitments in the amount of \$17,122,250.
