The SEC alleged that, prior to July 2022, Sound Point’s written policies and procedures regarding the prevention of misuse of potentially material non-public information were not sufficiently implemented and enforced in certain circumstances when Sound Point traded the tranches of collateralized loan obligations it managed. The SEC noted that Sound Point conducted compliance reviews prior to trades in tranches of collateralized loan obligations after July 2019, but alleged that Sound Point had not established, maintained or enforced written policies and procedures in respect of such reviews prior to July 2022. The SEC also alleged that, prior to June 2024, Sound Point’s written policies and procedures regarding the prevention of misuse of potentially material non-public information were not sufficiently implemented and enforced in certain circumstances when Sound Point traded the tranches of collateralized loan obligations managed by third parties. Pursuant to an offer of settlement, the SEC found, and Sound Point neither admitted nor denied, that Sound Point violated Sections 204A and 206(4) of the Investment Advisers Act of 1940 and Rule 206(4)-7 thereunder. The settlement included a censure and a civil penalty of \$1.8 million. This matter did not include any findings of insider trading or misuse of material non-public information by Sound Point or its employees. Sound Point fully cooperated with the SEC in this matter, which related only to the implementation of certain compliance policies and procedures, the majority of which were modified in 2019.
