To comply with regulations applicable to the private sale in Canada of interests in certain of the Funds we manage, we are required to retain the services of a local registered dealer as an intermediary. Under provincial regulations in Canada, this dealer may be considered a placement agent, though the dealer has not endorsed such Funds or solicited such investments. Accordingly, for Holocene Advisors Master Fund Ltd., we answer ‘No’ in response to Item 5.L.(1)(d), but answer ‘Yes’ in response to Schedule D, Section 7.B.(1), Q28(a). Regulatory assets under management are reported as of December 31, 2025.
