In Section 1(I), newly listed website (<https://www.hamventuresusa.com>) relates solely to the firm’s venture capital business. The firm has a fixed-income investment division, which is not therein. Also note that the URL (or any part of it, such as “HAM Ventures”) is not a trade name/assumed business name. The number of employees listed in Item 5(A) and 5(B) is as of March 2026. Clients referred to in Item 5(C)(1) are not direct contractual counterparties of the firm, but for the sake of completeness are counted herein as indirect clients whose assets we advise. This answer relates solely to the firm’s advisory account clients, not discretionary account clients. The calculation referred to in Item 5(C)(2) is based not only on direct contractual counterparties of the firm but for the sake of completeness, include indirect clients whose assets we advise or manage. The calculation is solely based on the firm’s advisory account clients, not discretionary account clients. In Item 5(D), with the exception of the pooled investment vehicle listed in Section 7.B.(1) for which we serve as investment manager, our direct client should be categorized as “other investment adviser”. However, we categorized AUM by our direct client’s underlying clients. In Item 5(D)(f), we included the assets of a pooled investment vehicle whereby we were appointed by our client (the sponsor/operator of the vehicle) to invest a minimum of 30% and up to 50% of the vehicle’s committed capital. For the purposes of calculating the assets under management for this vehicle, we referenced (1) the total committed capital of such vehicle and (2) used the 50% figure as we reasonably believe that we will invest up to 50% of the vehicle’s committed capital. RAUM provided in Item 5(D), Item 5(F)(2), or Section 5.K.(3), asset type percentages given in Section 5.K.(1)(b), dollar amounts given in Item 9, and any references to number of clients or accounts herein are as of December 31, 2025. The term “Performance-based fees” in Item 5(E) refers to carried interest that may be applicable for venture capital related accounts or private funds. In Item 5(F), we do not consider assets under advisement as “non-discretionary” accounts under regular supervisory or management services. However, in our accompanying Form ADV Part 2A, we reported assets under advisement as of December 31, 2025 of \$439,323,861. For Item 5(F)(3), we consider the pooled investment vehicle disclosed in Item 5(D)(f), which is US domiciled, as our client and not the domicile of the limited partners (LPs) of the pooled investment vehicle, who are non-US domiciled. For Item 11, the disciplinary history of our advisory affiliates is limited to that of our direct parent company, Hanwha Asset Management Co. Ltd., and does not extend to our indirect parent companies (who are both foreign public companies based in South Korea) and other companies under the common control of

our direct or indirect parent companies. While we are not aware of any disciplinary actions to disclose herein, we operate independently from such advisory affiliates and are not well placed to fully ascertain such information. With regards to Section 5.K.(1)(b), supranational/local authority bonds, government guaranteed/government sponsored/supranational sectors, and structured products were included in the category of “investment grade corporate bonds” due to such instruments (i) not having a separate categorization herein and (ii) making up a relatively immaterial part of any portfolios they are included within. With regards to Item 7A/Section 7.A., we are indirectly controlled by Hanwha Corporation and Hanwha Life Insurance Co. Ltd., both foreign public/listed companies based in South Korea, with numerous US and non-US subsidiaries and affiliates engaged in a variety of financial industry activities. As such, we may be deemed to be related to other financial industry participants, including but not limited to, foreign investment advisory affiliates and domestic and foreign broker-dealers not listed herein (including but not limited to, Velocity Clearing, LLC and Hanwha Investment & Securities Co. Ltd.). These related persons are not listed in our response to Section 7.A because (1) we have no business dealings with these related persons, (2) we do not conduct joint operations with such related persons, (3) we do not refer clients or business, in whole or in part, to the related persons, and the related persons do not refer prospective clients or business, in whole or in part, to us, (4) we do not share supervised persons or premises with the related persons, and (5) we have no reason to believe that our relationship with the related persons presents any potential for conflict of interest with our clients. For the purpose of this Item 7/Section 7.A, we focused only on related persons within our direct line of ownership above us and below us, but a list of related persons is available upon request. The entity “Hanwha-8090 GP LLC” that is newly disclosed in Section 7.A. is a general partner for a new private fund that is not yet in operation and has no committed capital or assets as of the date of this filing. For Item 7(B)/Section 7.B.(1), we did not include Hanwha-8090 Nexus Growth Fund LP, a private fund for which we will serve as investment manager and which Hanwha-8090 GP LLC will serve as general partner for. The fund is not yet in operation, has no committed capital or assets as of the date of this filing, and has not yet hired an auditor, custodian, or administrator. In relation to the related persons disclosed in Section 7.A. Question 11, our supervised persons may occasionally be asked to (i) provide input on strategic business concerns of our related persons (who are direct or indirect parent companies of the registrant or companies under the common control of our direct or indirect parent companies) or (ii) help facilitate or attend meetings in the United States on behalf of such related persons. The registrant and its supervised persons are not compensated for such matters, which are informal, ad hoc, and provided upon request of our related persons. Our supervised persons do not provide investment advice in relation to any such activities. Therefore, we have not answered “Yes” to Section 7.A, Question 11. With regards to Section 7.B.(1) Question 20, the investors who are beneficially invested in the private fund are not direct clients of the firm, nor direct investors of the private fund. Such investors’ investment in the private fund is indirect via an investment fund managed by an affiliate of the firm, but for the purposes of calculating the percentage of our clients who have also invested in the private fund, we did not consider such investment fund nor the affiliate as our clients, but instead considered the underlying investors of such investment fund as our "clients". Such investors are also not direct contractual counterparties of the firm in respect of investment advisory or investment management agreements/entrustment agreements, but were deemed “clients” for the purposes of answering this question since we advise or manage assets of such investors indirectly under such investment advisory or investment management agreements/entrustment agreements. For the purposes of calculating the answer, we did not consider the private fund’s general partner (which has provided the general partner’s required capital commitment to the private fund) as a client of the firm which has also invested in the private fund. Since this figure was disclosed in prior years, we did not recalculate this figure for this year’s filing because the fund is closed to new investors and the firm did not solicit new investors for the fund during 2025. For Section 7.B.(1) Question 23(b), the fund did not change auditors. Our auditor Moss Adams LLP merged with Baker Tilly LLP in June 2025, and now does business under the name Baker Tilly US LLP. For Item 9(A), as investment manager to the private fund listed in Section 7.B.(1), we consider ourselves as having custody of the fund’s cash and securities. For the purposes of Item 9(B), since our fully-owned subsidiary disclosed in Section 7.B.(1) serves as general partner to the private fund listed therein, we considered this a related person that has custody of the private fund’s cash and securities. For the purposes of Item 9(F), we did not consider (1) advisory accounts (i.e. accounts where we have no discretion and do not provide execution services for) or (2) a venture capital discretionary account where the client did not appoint a custodian (but maintains a bank account for the account’s cash). For Item 9(B)(2), with respect to a discretionary account we serve as investment manager for that is a private fund operated by an affiliate, we consider the affiliate as a related person with custody. The figure shown is the AUM for an account referred to in Item 5(D)(f). In last year’s filing, we considered the General Partner of our Private Fund a “related person” who had custody, but since the assets of that Private Fund are already covered in Item 9(A)(2), we decided not to consider that as a “client” for the purposes of answering Item 9(B)(2). For Schedule B (Indirect Owners), the entity shown, while not technically a public reporting company within the meaning of Section 12 or 15(d) of the Exchange Act, is a foreign public/listed company based in South Korea. Further ownership information is not shown since a public reporting company was reached. OTAA 4/30/26-7.B.(1)11 and 9(A)(2) changed from \$117,683,354 to \$109,848,083 upon receipt of audited 2025 financials as the previous figure was unaudited. The revised answer also now accounts for cash/cash equivalents and interest receivable and not solely investments, and is now based on cost basis of investments as the fund’s management fees are calculated on aggregate capital commitments and not fair value.
