Long Arc Capital LP is under common control with Robertson Stephens Wealth Management, LLC and Robertson Stephens Capital Market, LLC as the General Partners are each managed by Gaurav Bhandari. Long Arc Capital LP has also reported Robertson Stephens Wealth Management, LLC as a related person for the purposes of Item 7.A as Long Arc Capital LP may refer prospective clients to Robertson Stephens Wealth Management, LLC, and advisory representatives or Robertson Stephens Wealth Management, LLC may also refer prospective private fund investors to Long Arc Capital LP.
