Both the registrant and Related Adviser comply with one global compliance program and all clients (both U.S. and non-U.S. clients) are subject to the provisions of the Advisers Act. Item 5L(b)- marketing materials are targeted at institutional investors, not retail. Case studies (stock stories) are used are selected based on the fact that they are material holdings in the portfolio, and where they are relevant to the "theme" that we are discussing eg. data centres or residential housing. We may include extracted performance for this purpose.
