Additionally, Banner Ridge Secondary Master Fund IV, LP ("Fund IV") and Banner Ridge Secondary Master Fund V, LP ("Fund V") have invested a portion of their assets in Diversified Value Preferred II, LP. As such, the gross assets figure reflected in Section 7.B.(1) for Diversified Value Preferred II, LP has been reduced by Fund IV and Fund V's investment in the fund and is instead included in the gross assets figure of Fund IV and Fund V, respectively.
