ITEM 8.G. KA Credit has no formal arrangements with specific broker-dealers to receive “soft dollar benefits” beyond transaction execution in exchange for brokerage commissions from client transactions. However, KA Credit may pay a brokerage commission in excess of that which another broker might have charged for effecting the same transaction if KA Credit determines in good faith that the amount of commission is reasonable in relation to the value of the brokerage and research services provided by the broker-dealer, viewed in terms of either the particular transaction or KA Credit’s overall responsibilities with respect to the account over which it exercises investment discretion. Such rates are commensurate with those paid to so-called “full service” sell-side firms. KA Credit’s policies prohibit contractual third-party soft dollar arrangements pursuant to a Commission Sharing Agreement or equivalent.
