(1) With respect to the executive officers of the Adviser’s affiliate Two Sigma Investments, LP ("TSI"), please note the following: As of March 16, 2026, Dr. Siegel designated Seth Platt as his Executive Manager on the Management Committee of Two Sigma Management, LLC, the general partner of Two Sigma Real Estate, LP ("TSRE"), and as co-CEO of TSI. There is disagreement about whether, when designated, an Executive Manager becomes a co-CEO of TSI or whether the appointment of a co-CEO of TSI requires approval by both members of the Management Committee. Further, Mr. Platt has moved to terminate the current co-CEO of TSI given his view that the current co-CEO undermined his authority as Executive Manager. Mr. Overdeck believes Mr. Platt’s actions in this regard are imprudent and baseless and has placed the termination into dispute resolution, which means that the termination cannot take effect without Management Committee agreement or resolution through arbitration. (2) All asset, ownership, and related information is calculated as of December 31, 2025, while other information is provided as of the filing date. Two of the private funds advised by TSRE as of the filing date and reported in Schedule D, Section 7.B (1), TSRE Coinvest V LLC ("Coinvest V") and TSRE Coinvest VI LLC ("Coinvest VI"), commenced operations in March 2026. Therefore, as of December 31, 2025, (i) gross asset values and beneficial ownerships of zero are reported for Coinvest V and Coinvest VI in Schedule D, Section 7.B.(1), (ii) TSRE has no regulatory assets under management or custody of cash or securities attributable to Coinvest V and Coinvest VI in Item 5 and Item 9, respectively, and (iii) Coinvest V and Coinvest VI are not reported as clients in Item 5. Further, as newly created private funds, Coinvest V and Coinvest VI, along with another private fund which commenced operations in December 2025, TSRE Coinvest IV LLC ("Coinvest IV"), are not subject to annual audits for the year ending December 31, 2025, as reported for Question 23(a) of Schedule D, Section 7.B.(1). However, TSRE expects to engage an auditing firm for financial statement audits of Coinvest IV, Coinvest V and Coinvest VI for the year ending December 31, 2026. TSRE also manages an affiliated proprietary vehicle that invests in certain of the private funds that are included in Schedule D, Section 7.B.(1), but is not separately included in Section 7.B.(1) as a private fund or reflected in Item 5 as a client.
