SEPARATELY, THE BCC SUBCOMMITTEE DETERMINED THAT DUNN CAPITAL MAY HAVE VIOLATED EXCHANGE RULE 4.01(A) BY FAILING TO SUPERVISE THE EXCHANGE-RELATED ACTIVITIES OF THE FORMER EMPLOYEE. DUNN CAPITAL DID NOT PROFIT FROM THE FORMER EMPLOYEE'S ACTIVITY. DUNN CHOSE TO SETTLE THE MATTER WITH A SETTLEMENT OF \$40,000 RATHER THAN LITIGATE THE ALLEGATION. THE TRADER INVOLVED RESIGNED AND WAS SUSPENDED FROM TRADING ON THE ICE FUTURES US EXCHANGE FOR SIX MONTHS.
