While the definition of “Control” in the Form ADV would presume control, JH does not have or exercise a controlling influence over the management or policies of PC or Privacore Capital Advisors, LLC. Therefore, for the purpose of Item 7.A.6, 7.A.7, Item 12.C and Schedule B, we have selected “no” for control, while still providing information about JH entities in Item 7.A., Item 10.B, Item 11, Schedule B, and Disclosure Reporting for the purposes of disclosure and completeness. Similarly, the newly added Jupiter entities in Schedule B do not have or exercise a controlling influence over the management or policies of PC or Privacore Capital Advisors, LLC.
