("WTAM") ENTERED INTO A SETTLEMENT WITH THE SEC RELATED TO ALLEGED MISSTATEMENTS BY WTAM REGARDING THE ESG SCREENING PROCESS EMPLOYED BY THREE EXCHANGE-TRADED SERIES OF WISDOMTREE TRUST MANAGED BY WTAM (THE "FUNDS"). THE FUNDS WERE LIQUIDATED IN FEBRUARY 2024. WTAM ENTERED INTO THE SETTLEMENT WITHOUT ADMITTING OR DENYING THE SEC'S ALLEGATIONS THAT WTAM VIOLATED SECTIONS 206(2) AND 206(4) OF THE INVESTMENT ADVISERS ACT OF 1940, AND RULES 206(4)-7 AND 206(4)-8 THEREUNDER, AND SECTION 34(B) OF THE INVESTMENT COMPANY ACT OF 1940.
