WHEN SHE SENT IN THE CERTIFICATES, THEY WERE CERTIFICATES FOR GALLAHER GROUP, PLC. CUSTOMER APPARENTLY IS IN THE EARLY STAGES OF [REDACTED] DISEASE AND HAS GREAT DIFFICULTY REMEMBERING EVENTS AND THE SEQUENCE OF EVENTS. PRUDENTIAL APPARENTLY TOOK ADVANTAGE OF THIS TO "CREATE" A COMPLAINT WHICH THEY PAID WITHOUT AND INPUT, PARTICIPATION OR INVOLVEMENT BY ME. IN JANUARY OF 1998, WHEN REVIEWING THEIR ACCOUNT STATEMENT, THEY CONCLUDED THEY DID NOT AUTHORIZE THIS TRADE AND ASKED THAT IR BE REVERSED. LATER, THE CUSTOMERS TRANSFORMED THEIR COMPLAINT INTO ONE FOR \$18,000 SOLELY AS A RESULT IN PRICE OF A POSITION IN DANKA SECURITIES HELD IN THEIR ACCOUNT. I HAD



RECOMMENDED DANKA TO THE CUSTOMERS BECAUSE OF THE VERY STRONG RECOMMENDATION MADE BY PRUDENTIAL'S ANALYST, ALEX HENDERSON, THIS MATTER WAS SETTLED BY PRUDENTIAL WITHOUT MY INVOLVEMENT AND WITH NO PARTICIPATION BY ME WHATSOEVER. PRUDENTIAL HAS SOUGHT INDEMNITY FROM ME AND I HAVE DENIED ANY LIABILITY AND FILED A COUNTERCLAIM AGAINST PRUDENTIAL FOR BOTH WRONGFUL DISCHARGE AND DEFAMATION.
