IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THE SETTLEMENT AMOUNT REFLECTS THE PAR VALUE OF THE REPURCHASED ARS, IN ACCORDANCE WITH FINRA REGULATORY NOTICE 09-12, AND A \$225 FINRA FILING FEE. THIS MATTER WAS SETTLED SOLELY TO AVOID THE COSTS OF ARBITRATION, AND DESPITE THE LACK OF ANY MERIT TO THE CLAIM. THE CLIENTS PURCHASED ARS MANY TIMES BEFORE, AND EXPRESSLY REQUESTED THIS ADDITIONAL ARS PURCHASE DESPITE BEING TOLD SEVERAL TIMES BY THE FIRM AND BY THE FINANCIAL ADVISOR ABOUT THE ILLIQUIDITY IN THE ARS MARKET.
