AWARD WAS ROUGHLY 10% OF ALLEGED DAMAGES, CUSTOMER WAS RESPONSIBLE FOR HIS OWN ATTORNEY FEES (\$166,983), FORUM FEES (\$6,075) AND EXPERT FEES. PANEL CONCLUDED THAT PORTFOLIO WAS NOT SUFFICIENTLY HEDGED; HOWEVER, PRINCIPAL HEDGING WAS DONE THROUGH KEMPER VARIABLE ANNUITY WITH COMMUTABLE INCOME BENEFIT OPTION. IN 2007 AND 2008, 2 AND 3 YEARS AFTER THE ARBITRATION AWARD, CLAIMANT RECEIVED OVER \$922,126 FROM THE KEMPER ANNUITY DUE TO PROPER HEDGING BY MR. LORIO.
