CLIENTS & RR MET IN MAY 2008 TO DISCUSS INVESTMENT ALTERNATIVES AND INDICATED THAT THEY WERE WILLING TO ASSUME A MODERATE LEVEL OF RISK TO SEEK INCOME-PRODUCING INVESTMENTS. CLIENTS HAD APPROXIMATELY ONE MONTH TO CONSIDER THE VARIOUS RECOMMENDATIONS(INCLUDING TREASURY SECURITIES, ANNUITIES, BONDS/BOND FUNDS, PREFERRED STOCK, AND AN ADDITION TO AN EXISTING INVESTMENT) AND ELECTED TO PURSUE AN INVESTMENT IN FANNIE MAE & FREDDIE MAC PREFERRED STOCK. CLIENTS PREFERRED STOCK WAS SUBSEQUENTLY SUBJECT TO A SUBSTANTIAL (UNREALIZED) DECREASE IN VALUE WHICH HAS LED TO THIS CLAIM OF UNSUITABILITY. SUITABILITY IS DETERMINED AT THE POINT OF SALE AND NOT AT SOME LATER DATE WHEN INVESTMENT LOSSES HAVE BEEN INCURRED. BASED ON PUBLICLY-AVAILABLE INFORMATION AT THE POINT OF SALE (INCLUDING, CONTEMPORANEOUS STATEMENTS FROM REGULATORS AND THE HOUSE FINANCIAL SERVICES COMMITTEE CHAIRMAN INDICATING A BELIEF THAT THESE COMPANIES WERE "ADEQUATELY CAPITALIZED" AND/OR "FUNDAMENTALLY SOUND) RR COUND NOT REASONABLY BE EXPECTED TO HAVE KNOWN OF THE IMPACT OF THE COMPANIES LATER BEING PLACED INTO CONSERVATORSHIP ON THE CLIENTS' HOLDINGS. ACCORDINGLY, CLIENTS' CLAIM HAS BEEN DENIED.
