### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

refund on a 1035 transaction due to alleged failure of the representative to explain the costs of the transaction. After a thorough review, the Firm determined that the representative provided the client with appropriate information to make an informed decision regarding the transaction. The Firm denied the client's request for a refund on 08/28/19. On 11/20/19, the client submitted a second complaint to the Firm regarding the same 1035 transaction, requesting a larger refund than requested in their 08/01/19 complaint due to their new allegation that the representative churned their account. Upon review of the client's second complaint, the Firm determined the representative was acting in the client's best interest and found no evidence of churning or wrongdoing on behalf of the representative. The client's second request for a refund was denied by the Firm.
