IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

CLIENT STATES SHE HAD CONSULTED ANOTHER ADVISOR AND WAS INFORMED THIS INFORMATION WAS INCORRECT. CLIENT INDICATES BASED ON THIS ADVICE SHE WOUND UP PAYING MUCH MORE IN INCOME TAX IN 2007 AND 2008 (\$22,175 AND \$8,817 RESPECTIVELY). IN ADDITION CLIENT CLAIMS HER MEDICARE PART B WAS ALSO AFFECTED PAYING \$1,387 AND \$693 MORE IN INSURANCE PREMIUMS. FILING REQUIRED, LOSSES CLAIMED EXCEED \$5,000.

CLIENT'S REQUEST FOR REIMBURSEMENT OF \$33,072.00 IS RESPECTFULLY DENIED.
