IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: DURING THE SPRING OF 1989, [CUSTOMER] ACTING ON BEHALF OF [CUSTOMER],HIS WIFE, ALLEGED THAT WHILE ACTING AS A STOCKBROKER FOR THEIR ACCOUNT AT WEDBUSH, MR. YOUNG FAILED TO FOLLOW HIS INSTRUCTIONS BY RECOMMENDING RISKY STOCKS,FAILED TO PLACE STOP LIMITS ON ORDERS TAKEN AND HAD "INSIDE INFORMATION" BECAUSE HE INVITED [THIRD PARTY], THEN CEO OF CIRCLE K TO SPEAK AT A SEMINAR. A LETTER, THROUGH MR. YOUNG'S COUNSEL WAS SENT TO [CUSTOMER] AND HIS WIFE DENYING ANY WRONGDOING AND THAT MR. YOUNG ACTED APPROPRIATELY. SUBSEQUENT TO THE ARBITRATION DECISION, A LETTER WAS SENT TO MR. YOUNG BY CLAIMANT'S ATTORNEY,VICTORIA GROOVER RETRACTING CERTAIN ALLEGATIONS. YOUNG IMMEDIATELY WROTE THE NYSE AND NASD REQUESTING A REVIEW OF THE MATTER AND THE REQUEST WAS DENIED BECAUSE THE ARBITRATION DECISION HAD BEEN RENDERED.

Allegations: IN FEBRUARY OF 2001, [CUSTOMER] WROTE TO YOUNG CAPITAL MANAGEMENT AND CLAIMED THAT HIS ACCOUNT HAD BEEN MISMANAGED. YCM THROUGH ITS COUNSEL, RESPONDED TO [CUSTOMER] BY A LETTER DATED MARCH 21, 2001. THAT LETTER EXPRESSED DISAPPOINTMENT THAT [CUSTOMER'S] ACCOUNT, AS WAS THE CASE WITH VIRTUALLY ALL STOCK MARKET INVESTORS, HAD NOT FARED WELL IN LATE 2000. THE LETTER ALSO CONTAINS A CLEAR EXPLANATION THAT YCM AND YOUNG HAD NOT BREACHED ANY DUTIES, HAD NOT ENGAGED IN ANY WRONGFUL CONDUCT, AND WERE IN NO WAY LIABLE FOR ANY UNREALIZED OR REALIZED LOSSES IN THE ACCOUNT. THE MARKETS HAVE CONTINUED TO SUFFER SINCE THEN. THE FACTS AND THE TOTAL ABSENCE OF ANY BASIS TO IMPOSE LIABILITY ON YCM, HAVE NOT CHANGED.
