Kelly neither admitted nor denied the findings but consented to the entry of findings by the Office. The Office found that Sean P. Kelly failed to comply with the custody requirements of the Florida Securities and Investor Protection Act, Chapter 517, F. S. A \$7,500 administrative fine was paid jointly and severally with Kelly & Associates, LLC.
