What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Without admitting any liability, the Firm settled the matter for \$25,000 to avoid further costs of arbitration. **The client had a long term relationship with A G Edwards and then Wells Fargo Advisors. She inherited a concentrated position which represented between 25-50% of her account value and was very attached to the stock. In an effort to meet her income and diversification needs we use an outside investment manager to potentially increase her income and hedge the concentrated position. While her position was managed by the outside manager her account value grew by approximately 40%.
